



## YOUTH (UNDER 18) WAIVER OF LIABILITY, RELEASE, & ASSUMPTION OF RISK

Parent or legal guardian of the volunteer youth must sign this waiver!

Habitat for Humanity of Hood County, (Habitat), encourages minors to help on Habitat construction sites. Their activities, however, are limited to what is deemed safe for minors by the Texas Workforce Commission Child Labor Laws, Habitat for Humanity International, and Habitat's insurance carrier.

I, individually and as parent or guardian of the minor listed below (hereinafter the "Minor"), understand that building construction involves certain risk and dangers of accidents, including death and permanent disability, and property loss and damage. I, individually and as parent or guardian of the Minor, voluntarily and knowingly choose to accept and assume such risks and dangers, both known and unknown, associated with volunteering for Habitat for Humanity of Hood County ("Habitat") and even if arising from the negligence Habitat and/or its board members, directors, officers, employees, volunteers, representatives and agent (the "Released Parties").. I understand that, as a volunteer, I am not covered by Workers Compensation Insurance. I accept full responsibility for my own safety and the safety of the minor listed below, and I acknowledge that this Waiver of Liability, Release, and Assumption of Risk shall govern my actions and responsibilities while volunteering for Habitat..

I, individually and as parent or guardian of the minor listed below, understand that Habitat, the Group (as defined below), and the Released Parties will not be liable for any injuries or illness that I or any of my dependent(s) may suffer which arise directly or indirectly from my work with Habitat, the Group, or Released Parties, regardless of the negligence or fault of Released Parties or the Group.

I, individually and as parent or guardian of the minor listed below hereby expressly INDEMNIFY, RELEASE, AND HOLD HARMLESS Habitat, the Group, and the Released Parties from any and all claims for compensation or liability arising out of an injury, illness, or death that I or my dependent(s) may sustain, directly or indirectly, in connection with the work I will be doing with Habitat and the Released Parties, and hereby WAIVE, RELEASE AND AGREE TO HOLD HARMLESS Habitat and the Released Parties of and from any and all liability or claims or cause of action for personal injury, illness, medical expense, or death arising from or caused by any act or omission of Habitat, the Group, the Released Parties, or myself, while volunteering for Habitat.

Due to the risks associated with building construction, I hereby consent to receive medical treatment which may be deemed available in the event of injury, accident, and/or illness while working with and volunteering for Habitat. In addition, I INDEMNIFY, RELEASE, AND HOLD HARMLESS the Released Parties from any liability or claim arising out of first aid, treatment, and medical services rendered while working with and volunteering for Habitat, and such waiver and indemnification extends to all periods of construction or any other volunteer work that I perform on behalf of Habitat.

I do hereby grant all right, title, and interest I may have in any and all photographic images, and video/audio recordings, created by Habitat or its agents or employees during my work for Habitat including (but not limited to) any royalties, proceeds, or other benefits derived therefrom.

This Waiver of Liability, Release and Assumption of Risk Form shall be governed by Texas law and constructed broadly to provide a release and waiver to the maximum extent.
